

How to Join Helta eV

Membership dues are €40 annually, based on a calendar year, January – December. Entrance fees at most events are free for members; if staging an event involves high costs for the association, members may be asked to pay a modest fee. Whenever publishers are presenting teaching material, entrance is free.

HELTA eV is an independent non-profit association, registered with the *Amtsgericht*. We are not sponsored by any organization; our activities are funded by membership fees, and the association is run by a team of elected volunteers.

Members can cancel any time between January and April 15 for the current calendar year. After the direct debit in mid-May, there is no refund for a cancelled membership for the remainder of the calendar year.
